## CASE STUDY: 1.1 MILLION FOR BEMAX ON THE EVE OF ELECTION

I: INTRODUCTION: In a two- and-a-half-month pre-election period, on the eve of 2012 early parliamentary election, the construction company "Bemax" received around €1.1 million from the state treasury for the local infrastructure works, while merely €47 was approved in the remaining months of the same year.

Investing in local infrastructure is a significant mechanism for pre-election bribery because in exchange for their votes the voters get infrastructure facilities that improve the quality of living.

II: €1.1 MILLION TO BEMAX IN PRE-ELECTION PERIOD: Early parliamentary election was called for 31 July 2012, and were held on 14 October of the same year, so during that period the pre-election campaign in progress. According to official data from the state treasury, in August 2012, during the pre-election period, the company "Bemax" was granted 12 payments totaling €1,076,401, whereas in September a sum of €4,350 was approved and €12,902 in October.

In August, two payments totaling €56,500 were approved for modernization of the road in the municipality of Mojkovac,¹ then a sum of €219,700 was allocated for the reconstruction of Bridge Niko Strugar over the river Lim,² €164,100 for reconstruction of the bridge at the river Lim near Rijeka Marsenica³ and a total of € 209,600 for the reconstruction of Bridge Novsici.⁴ In the same month, €167,600 was approved for the construction of a bridge in the village Seoce, over the river Lim,⁵ €106,400 for works on modernization of the local roads in the municipality of Pljevlja,⁶ whereas for modernization of the local roads in the municipality of Pljevlja an additional sum of €11,800 was approved and €140,300 for modernization of the local road Piperi-Kovacevici on the road section Piperi-Lugovi.¹

In September, €4,300 was approved for modernization of the local road on Lugovi-Mjesna zajednica Bukovica, and in October, €12,900 for mitigating the landslides at the road Piperi Kovacevici-Mjesna zajednica Bukovica.

Money from the Treasury was withdrawn from the funds of two loans, the beneficiary of which was the Ministry of Sustainable Development and Tourism. These were the loans for building local infrastructure and emergency relief and flood prevention.

The company Bemax was granted a loan totaling €332,400 for local infrastructure construction-modernization of the local roads in Mojkovac, Pljevlja and Bukovica. At the same time, from the loan for Emergency Relief and Flood Prevention, a sum totaling €761,100 was approved to the Podgorica-based company for building bridges in Plav, Andrijevica and Berane.

**III: MERELY TWO PAYMENTS FOR "BEMAX" IN NON-ELECTION PERIOD:** In the non-election period of the year, "Bemax" was approved only two payments. Thus, in November, €42,900 was approved for modernization of the local roads in the municipality of Berane<sup>10</sup> and in December another €4,700 for the same purpose, 11 totaling €47,700.

IV: IN PRE-ELECTION PERIOD THE COMPANY "DONATED" WORKS: During August and September 2012, Bemax built and reconstructed several local roads in Bijelo Polje, Kolasin and Podgorica through donation, with the approval of the local authorities, although it is contrary to the Public Procurement Law, having in mind that no project on infrastructure facilities can be implemented without a call for public bid.

Thus in Bijelo Polje *Bemax* "donated" the construction of an underground railway crossing and two sidewalks through Sutivan and Ribarevine, officially spending about €200,000. In August 2012, this company "treated" the local government to the reconstruction of the road in the suburb of Seliste, but the value of these works is unknown.¹² Expressing satisfaction over the "donation", the mayor of Kolasin, Darko Brajuskovic, said that he "hopes that the Bemax's construction machines will not leave the city".

In addition, *Bemax* reconstructed a local road in Podgorica, in the village Farmaci, which was being announced for several consecutive years, and was implemented just before the early parliamentary election in October 2012. The Podgorica-based company *Bemax* was founded in 2007 and in the coming years it started winning most valuable public tenders in the field of infrastructure.
